(Victim's Economic Safety & Security Act)**

Did you know that Illinois law requires most Illinois employers to give domestic violence victims time off to find safe housing, go to court, and otherwise attend to their safety? The law also prohibits an employer from firing a worker because she is a Domestic Violence victim or because the abuser has shown up at the workplace. VESSA was recently amended to extend its coverage to very small employers.
